Lanny Nickell

President and CEO, Southwest Power Pool

Lanny Nickell is President and Chief Executive Officer for Southwest Power Pool (SPP), a

Regional Transmission Organization whose member utilities operate primarily in the Central United States. Under his leadership, SPP ensures affordable wholesale electric power is continuously delivered to 18 million people, today and in the future. Lanny joined SPP in 1997 and previously served at Chief Operating Officer, Vice President of Engineering, and Vice President of Operations.

Lanny received a Bachelor of Science degree in Electrical Engineering from the University of Tulsa and is a graduate of Harvard Business School's Advanced Management Program.

Prior to joining Dominion, he worked in government relations for the Edison Electric Institute. He also spent more than 10 years working on Capitol Hill covering a range of issues, including energy and the environment.

Cy McNeill

Director, Federal Energy Policy, Data Center Coalition

Cy McNeill is director of federal energy policy for the Data Center Coalition

(DCC), the membership association serving as the voice of the U.S. data center industry.

Before joining DCC, Cy worked in the regulated energy sector and in public service, most recently with Alliant Energy in Washington, DC. Cy managed the company's federal regulatory strategy and advocated before Congress and the executive branch on issues such as electric transmission, siting and permitting reform, energy market design, and foreign trade. Cy also led engagement efforts for the company with trade association regulatory and policy committees, as well as coalition building among consumer groups, state regulators, and clean energy developers to advance key policy priorities.

Prior to Alliant Energy, Cy spent time serving in the federal government working for the Department of Commerce and FERC. While at FERC, Cy advised the commission on issues such as tax reform implementation and wholesale gas market policy. Additionally, he provided testimony on litigated cases before the agency.

Cy holds a Bachelor of Arts degree in Economics from Salisbury University.

Aubrey Johnson is VP of System & Resource

Planning, Competitive Transmission at MISO. He oversees all aspects of transmission planning, resource planning, and SEAMS Strategy to meet MISO's future system needs. Aubrey is responsible for the planning process that yields the annual MISO Transmission Expansion Plan, including reliability, economic and interregional planning, transmission cost allocation, resource adequacy, resource utilization, and the competitive transmission developer selection and monitoring process.

Aubrey's background spans more than 30 years in the energy industry. He served as Vice President of New Mexico Operations at the Public Service Company of New Mexico. Prior to that he held various positions at GE Energy Services and Southern Company.

Aubrey holds a Bachelor of Science, Mechanical Engineering from Tuskegee University.

PANEL 2 – ENERGY DECISION-MAKING IN THE NEW ADMINISTRATION AND THE ROLES OF FERC, DOE & THE NATIONAL ENERGY DOMINANCE COUNCIL

Craig Glazer

VP of Federal Government Policy, PJM Interconnection

Craig Glazer serves as the Vice President-Federal Government

Policy for PJM Interconnection. In this capacity, Craig coordinates all of PJM's regulatory and legislative policies before Congress, FERC, the U.S. Department of Energy and other federal agencies. PJM operates the largest competitive wholesale electricity market in the world and serves over 9% of the U.S. population. Craig heads PJM's Washington, D.C. office.

Prior to coming to PJM, Craig served as Commissioner and Chairman of the Public Utilities Commission of Ohio. As one of the longest-serving Chairs of the Ohio Commission in its history, he oversaw Ohio's move toward deregulation of its telephone, natural gas, transportation and electric industries. Craig served as CEO of the agency which operated with over 300 employees and a budget of \$25 million. He also chaired the state's Siting Board and served as a member of the Governor's Cabinet.

Craig remains extremely active on national electricity issues. He frequently testified before Congress and FERC on development of RTOs

and the needs of the marketplace. He served as a member of the Board of Directors of the National Association of Regulatory Utility Commissioners, Chairman of its International Relations Committee and a member of its Electricity and Energy Resources Committees. He also chaired the National Council on Competition in the Electric Industry, an interagency collaborative which brought together FERC, the state PUCs, the U.S. DOE, the U.S. EPA and the National Council of State Legislatures.

Craig is a graduate of the University of Pennsylvania and the Vanderbilt University School of Law.

Maria Robinson

Former Director of DOE Grid Deployment Office

Maria Duaime Robinson was the Former Director of the U.S. Department of Energy's Grid Deployment

Office. Maria was the first Korean-American elected to the Massachusetts General Court, where she served in the House of Representatives from 2019-2022. While in office, she led the bicameral Clean Energy Caucus, was the Massachusetts state lead for the National Caucus of Environmental Legislators where she also served on the board, and was the only state legislator on the U.S. EPA Clean Air Act Advisory Committee. She also served on faculty at Tufts University's School of Urban Planning and Environmental Policy, bringing her expertise in energy policy to graduate students. Prior to her election in 2018, Maria led Advanced Energy Economy's Wholesale Markets Program, including engagement at FERC and the regional transmission organizations.

Previously, Maria focused on regulatory issues relating to energy and air, including a 27-state campaign with Governors' offices, legislatures, and energy and environmental regulators. She also managed AEE's report

development and data-driven analysis at both the state and national level. She worked for Navigant Consulting in the renewable energy practice, supporting the Commonwealth of Massachusetts in analyzing and procuring contractors for statewide renewable energy and energy efficiency projects.

Maria is a proud lifetime Girl Scout. She holds an S.B. in Chemical Engineering from the Massachusetts Institute of Technology and a Masters of Jurisprudence in Energy Law from the University of Tulsa.

Norman C. Bay is a partner in the Corporate

and Financial Services Department, Chair of the Energy Regulatory & Enforcement Practice Group, and Co-Chair of the Energy & Commodities Practice Group at Willkie Farr & Gallagher.
